I refer to your application as an upper tier waste Carrier/Broker which has now been approved by the Northern Ireland Environment Agency.



I wish to advise you that during the period of this registration if the department is not satisfied that a person is fit to hold or continue to hold a registration, it may decide to revoke the registration or refuse to issue any further authorisations. Such action will be taken in accordance with the Departments policy on Relevant Convictions.
